

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

(Monday)** at **Philippine Navy Bids and Awards Committee, Naval Station Jose Francisco, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **Video Tele Conferencing (VTC) via Zoom Application. (Zoom Meeting ID: 965 038 3082; Password: SDr9Dz)** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
