Delivery of Goods is required **One Hundred Eighty (180) Calendar days Upon receipt of Notice to Proceed (NTP)** Bidders should have completed, within **Five (5) Years** from the date of submission and receipt of bids a contract similar to the Project. The description of eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. **Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.**
4. Prospective Bidders may obtain further information from Philippine Navy Bids and Awards Committee (PNBAC-2) and inspect the Bidding Documents at the address given below during, **Monday to Friday from 8:00 AM to 5:00 PM**

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bid opening shall be conducted via **blended/VTC on December 19, 2024, 09:00 AM, Thursday** at **Philippine Navy Bids and Awards Committee, Naval Station Jose Francisco, Fort Bonifacio, Taguig City**. Bidders *may physically attend* the opening and evaluation of bidding documents or through **Video Tele Conferencing (VTC) via Zoom Application. (Zoom Meeting ID: 965 038 3082; Password: SDr9Dz)** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The Philippine Navy reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
