WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Peculiar Equipment for Small Arms Ammunition Proofing and Rehabilitation Capability Development for Naval Ammunition and Explosives Center and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of NINE MILLION NINE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED PESOS (PhP9,998,500.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of NINE MILLION NINE HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED PESOS (PhP9,998,500.00) or such other sums as may be ascertained, Nashe Enterprises agrees to Supply and Delivery of Peculiar Equipment for Small Arms Ammunition Proofing and Rehabilitation Capability Development for Naval Ammunition and Explosives Center in accordance with his/her/its Bid.
4. The Philippine Navy, Armed Forces of the Philippines agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
