4. Prospective Bidders may obtain further information from Philippine Marine Corps Bids and Awards Committee (PMCBAC) and inspect the Bidding Documents at the address given below during, **Monday to Friday from 8:00 AM to 5:00 PM**.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be conducted via **blended/VTC on December 26, 2024, 9:00 AM, Thursday, Thursday at SMART House, PMCBAC Office, Marine Barracks Rudiardo Brown, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **VTC via Zoom application**. Meeting I.D: **260 106 2021** and Passcode: **162021** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
