

**Contract Agreement**  
**(307THCO-AMMO-044-07-2024-PMC)**

THIS AGREEMENT made this \_\_\_\_\_ between **Philippine Marine Corps, Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the entity") of the one part and **Rheinmetall Expal Munitions S. A.** at Avenida Del Partenon, 16 Madrid, Spain (Hereinafter called "the Supplier") of the other part:

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., for the project, "**Procurement of Ammunition for Newly Acquired Assets (600 Rds Ctg, 81mm: HE and 500 Rds of Ctg, 120mm: HE Ammunition within Four Hundred Eighty (480) Calendar Days** from Receipt of the Supplier of the Notice To Proceed under Project Nr: **AMMO-PNBAC2-2024-02** and has accepted a bid by the supplier for the supply of those supplies and materials in the sum of **Seventy Million Nine Hundred Thirty-One Thousand Twenty-Eight Pesos (Php70,931,028.00)** only. (hereafter called "the Contract Price").

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) Notice of Award of Contract and the Bidder's conforme thereto;
- (b) PNBAC Resolution
- (c) Post Qualification Inspection Report
- (d) Minutes of Submission and Opening of Bids Envelopes (SOBE)
- (e) Abstract of Bids
- (f) Eligibility and Technical Information
- (g) Financial Information
- (h) Invitation to Bid & other Bidding Documents
- (i) Minutes of Pre-Bid Conference
- (j) Certificate of Funding Chargeability
- (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


