PNBAC2 RESOLUTION No. 047-2024

Resolution Declaring KOREA VEHICLE AND INDUSTRY CO. LTD (KOVICO) as the Winning Bidder for the project “Procurement of Jeep (4X4) and APC Wheeled Ambulance/Rescue” and Recommending Approval of the NOA

WHEREAS, the Philippine Navy thru the Philippine Navy Bids and Awards Committee2 caused the advertisement of the Invitation to Bid (ITB) for the project “**Procurement of Jeep (4X4) and APC Wheeled Ambulance/Rescue**” at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website last 08 October 2024. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

WHEREAS, the PNBAC2 conducted public bidding on 050900 November 2024 at the PNBAC Conference Room, Naval Station Jose Francisco, Fort Bonifacio, Taguig City wherein two (2) bidders, **KOREA VEHICLE AND INDUSTRY CO. LTD (KOVICO)** and **URO VEHICULOS ESPECIALES S.A.** submitted the required Eligibility, Technical and Financial Proposals of the bid. All documents were found to be compliant and rated “**PASSED**” and subsequently declared as “**eligible**” bidders;

WHEREAS, after a detailed evaluation of the financial proposals submitted by the eligible bidders, the PNBAC2 found both the proposals compliant as to form and within the ABC of the project. Furthermore, **KOREA VEHICLE AND INDUSTRY CO. LTD (KOVICO)** was calculated to be the lowest, thus, it was declared the “**Lowest Calculated Bid**” subject to post qualification, to wit:

After thorough verification, validation and ascertaining all the statements made and documents submitted by

the bidder, the Post Qualification Team found and established the bid to be “**Responsive**” to the requirements of the project.


