

**CONTRACT AGREEMENT
(302CO-ORD-210-24)**

THIS AGREEMENT made this _____ between **Philippine Navy, Armed Forces of the Philippines** (hereinafter called "the Entity") of the one part and **MSM Export S.R.O. of Sturova, Dubnica nad Vahom Slovak Republic, Slovakia** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of 10,000 Rounds 30mm HEI Ammunition for PG901, PG902, PG903, PG905, FAIC05 and FAIC06** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED ONE HUNDRED NINETEEN MILLION FOUR HUNDRED THIRTY-FOUR THOUSAND EIGHT HUNDRED TEN PESOS (PhP119,434,810.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **ONE HUNDRED ONE HUNDRED NINETEEN MILLION FOUR HUNDRED THIRTY-FOUR THOUSAND EIGHT HUNDRED TEN PESOS (PhP119,434,810.00)** or such other sums as may be ascertained, **MSM Export S.R.O.** agrees to **Supply and Delivery of 10,000 Rounds 30mm HEI Ammunition for PG901, PG902, PG903, PG905, FAIC05 and FAIC06** in accordance with his/her/its Bid.
4. The **Philippine Navy, Armed Forces of the Philippines** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
