Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. **Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.**
4. Prospective Bidders may obtain further information from Philippine Marine Corps Bids and Awards Committee (PMCBAC) and inspect the Bidding Documents at the address given below during, **Monday to Friday from 8:00 AM to 5:00 PM.**

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be conducted via **blended/VTC on March 18, 2025, 9:00 AM, Tuesday** at **SMART House, PMCBAC Office, Marine Barracks Rudiardo Brown, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **VTC via Zoom application**. Meeting I.D: **260 106 2021** and Passcode: **162021** who choose to attend the activity. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

The Philippine Marine Corps reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
