PNBAC1 RESOLUTION No. 086-2025

Resolution Declaring COMMSOURCE SYSTEMS & INTEGRATED SOLUTIONS INC. as the Winning Bidder for the project "Subscription to Cyber Solutions Project" and Recommending Approval of the NOA

WHEREAS, the Philippine Navy thru the Philippine Navy Bids and Awards Committee1 caused the advertisement of the Invitation to Bid (ITB) for the project "**Subscription to Cyber Solutions Project**" at the Philippine Government Electronic Procurement System Website (PhilGEPS) and Philippine Navy Website last 29 November 2024. Likewise, it was posted at conspicuous places within the premises of the PNBAC Office continuously for seven (7) calendar days;

WHEREAS, the PNBAC1 conducted public bidding on 200900 December 2024 through Video Teleconferencing (VTC) wherein one (1) bidder, **COMMSOURCE SYSTEMS & INTEGRATED SOLUTIONS INC.** submitted the required Eligibility, Technical and Financial Proposals of the bid. All documents were found to be compliant and rated "**PASSED**" and subsequently declared as "**eligible**" bidder;
