8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be conducted via **blended/VTC on May 8, 2025, 09:00 am Thursday at SMART House, PMCBAC Office, Marine Barracks Rudiardo Brown, Fort Bonifacio, Taguig City**. Bidders **may physically attend** the opening and evaluation of bidding documents or through **VTC via Zoom application**.
